




After logging in, from the dashboard, select **Transactions** from the top menu.




Click on **New Transaction**.

Select the **Terminal** from the drop-down menu and enter the **Container Number**.




Scroll down to enter the **Pick-up Date**.


All fees that are due for the container from the APM terminal system are pulled and displayed. **Select the transactions you wish to pay** from the list by clicking the checkbox.




By selecting the **plus sign** to the left of the fee names, you will open **optional fields** in which your internal reference numbers can be entered for billing reconciliation.

Once complete, the details including the Demurrage fees and OSRA can be viewed by clicking on the transaction from the Transaction Page.




